1. To make a booking , please complete the form and return it either by e-mail or mail to our address above. Your booking comes into effect upon making a deposit of 50% of the price .The rest amount will be paid on the spot with the arrival in polytropon workshop.
2. If you cancel your booking you must notify us in writing. The cancellation of the booking only comes into effect upon receipt of the written notification from you and the following cancellation fees will be due:
Up to 60 days before commencement date: refund of deposit. 59-30 days before commencement date: refund 50% of deposit.
29-15 days before commencement date: refund 25% of deposit. Less than 14 days before commencement date: we keep deposit.
3. If we cancel or alter your courses within 14 days before the commencement date, we will offer the choice of an alternative date or a full refund of deposit. During the courses we reserve the right, if we consider it necessary, for any reason and any time to change the program according to weather, force majeure or other considerations.
Force Majeure is the unusual and unforeseeable circumstance beyond our control , the consequences of which we could avoid, examples of which are war, riots, civil strife, terrorist activity, industrial disputes, natural or nuclear disaster, fire or adverse weather conditions, level of water in rivers, or other similar events beyond our control.
4. Before you come on these courses you must be covered by insurance, which must include adequate cover for baggage, medical expenses and the cost of repatriation should you become too ill to continue.
5. During the courses you agree to indemnify us from any loss and/or damage arising directly /indirectly from any act of default on your own behalf.
6. It is your responsibility to ensure that your official documents are in order. Non EU residents should check visa requirements with their consulate, and obtain one if necessary.
7. It is also your responsibility to advise us in writing ,at the time of booking, of any medical or other ailment of allergy. We must also be notified of any special dietary requirement, as well as any other specific condition that requires specific treatment.
8. If you are prevented from travelling and wish to avoid cancellation charges you may transfer your booking to another person provided that this is completed at least 14 days before the commencement date. The person to whom the holiday is transferred must comply with all conditions and complete a booking form for the transfer to be in effect. The right to transfer is subject to payment of an administration fee of 50 euros. A transfer will not be possible if there is a waiting list.
9. If for any reason you decide not to travel rather than cancel your booking and incur cancellation charges, you may transfer your booking to another period. The option to transfer must be taken at least 30 days before the commencement date .The right to transfer is subject to an administration fee of 100 euros, payable within 7 days from the approval of the transfer. The period to which you wish to transfer your courses must be within 6 months from the original booked course.
10. Both the present terms and conditions and those contained in the course receipt are governed by the Hellenic law and any dispute arising in the context of those agreements will be exclusively brought before the competent Amfissa Court.
